GENERAL ORDER OF THE PRESIDING JUDGE

The Presiding Judge has designated locations for where the types of cases are to be filed and heard. To process filings in a timely manner, please locate the type of case and zip code that corresponds with the place of residence or where the incident occurred. This will identify the assigned courthouse to file and have the case heard.

All civil unlimited cases in San Bernardino County, including those designated as complex; all unlawful detainers filed as unlimited - alleging damages of \$25,000 or more (including cases for recovery of residential COVID-19 Rental Debt if the landlord chooses not to file the case in small claims court); all actions to recover COVID-19 Rental Debt involving commercial properties alleging damages of \$25,000 or more; and all probate matters shall be filed and heard in the San Bernardino Justice Center,

General Order: Where Civil Cases are Filed and Heard

- (a) Petitions for restraining orders (i.e., civil harassment, elder/adult dependent abuse, return of firearms, post-secondary school, and workplace violence, etc.) and name changes. All petitions for restraining orders and name changes shall be filed and heard in the following courthouses:
  - (1) San Bernardino Justice Center, Civil Division (with the exception of elder/adult dependent abuse filings, which are heard in the Probate Division), 247 West Third Street, San Bernardino, 92415.
